In addition to U.S. Army Corps of Engineers Rules and Regulations (36 Code of Federal regulations, Chapter III, Part 327), the following rules and regulations apply at Curwensville Lake Recreation Area.

#### **GENERAL RULES**

- Failure to comply with the following rules and regulations may result in eviction from the park and/or notification of law enforcement.
- The following items are strictly prohibited: All alcoholic beverages Drones of any size or type Fireworks, weapons and/or explosives Use of chainsaws
- Rules and regulations will be enforced by park manager, security, and staff.
- Visitors must follow posted speed limits.
- Pets are permitted provided they are restrained on a leash and under owner's control at all times. (*Shock collars are NOT accepted as a replacement for a leash*) Pets must be cleaned up after, and never be left unattended.
- Bicycles are permitted in the park. Operators must ride on the road in the direction of traffic and obey all traffic signs. Bicycles, skateboards, scooters, etc. without safety markings may not be used after sunset.
- Motorized vehicles are not permitted on trails, bridges, or sidewalks.
- Paved walkways are to remain accessible at all times. Parking is prohibited on paved sidewalks and entrances to pavilions.
- Please use barbeque grills located throughout the picnic grove and pavilions. Open fires must be built in fire rings only.
- Electric and gasoline powered "golf cart type" vehicles may be used for personal travel on park roads only by licensed operators. Must have front and rear lights and horn. Proof of liability insurance is required.
- The destruction, injury, defacement, or removal of park property is prohibited.

- The hanging of lanterns, tools, or trash bags from trees is prohibited.
- No foreign objects such as screws, nails, or spikes may be driven into trees.
- Cutting standing trees is prohibited. Firewood may be gathered from trees that are dead and fallen only. Firewood may be purchased from the park office, security, or staff.

### BOATING

- Swimming is prohibited in the boat launch area.
- All powered boats whether stored or operated at CLRA must be registered.
- All boat owners are responsible for removal of their boats in the event of flooding.
- Operating any watercraft within the swimming area is prohibited.
- All PA Fish and Boat Commission rules and regulations apply at Curwensville Lake.

### BEACH

- No pets are allowed at beach area.
- Swim at your own risk. There are no lifeguards.
- All swimmers must stay within the roped, designated area. Swimming after dusk is prohibited.
- Hours of operation for the beach and volleyball court are from dawn to dusk. Violators will be asked to leave the park.

## FISHING

- Fishing in the dog swimming area is prohibited.
- No fishing from public or private docks.
- All PA Fish and Boat Commission rules and regulations apply at Curwensville Lake.

#### CAMPING

- Full payment is required at time of reservation. If reservation is canceled within fourteen (14) days of stay, a one night charge will be forfeited. This charge may not be transferred to another stay. Reservations for Memorial Day, July 4<sup>th</sup>, and Labor Day are not refundable within 14 days of stay.
- Individuals registering must be 18 years of age and have a valid driver's license or photo ID. They are responsible for the actions of the site's occupants.
- A maximum of 6 people are permitted on each campsite. One tent may be set up for use by the registered camper's immediate family.
- Check-in is after 3:00 pm.
- Check-out is by 12:00 pm. Later check-out times may be requested but are not guaranteed.
- Arrangements to extend your stay must be made by 12:00 pm on check out day.
- Camping is permitted in designated areas only.
- Campers must register at the park office within one hour of arrival. When the park office is closed, campers must register with the office the following morning.
- Campfires must be built only in fire rings and must not be left unattended. Fire rings may not be moved or used for disposal of litter or trash.
- Campfires must be completely extinguished when vacating the campsite. Campsites must be cleaned before departure. Litter and trash shall be disposed of in trash dumpsters when exiting campgrounds.
- Only two (2) vehicles are permitted at any campsite. (A trailer with or without a boat is considered a vehicle.) Vehicles may not park on the grass at any time. Extra vehicles must be taken to the overflow parking area at the top of the hill. Parking of extra vehicles in unoccupied campsites is prohibited.

- Campground visitors must buy a day pass. All visitors must leave the campground by 10:00pm. The registered camper is responsible for their guest's conduct and actions.
- "Quiet time" is from 10:00 pm to 8:00 am. Please respect your fellow campers. Loud noise, talking, or music during quiet hours will not be tolerated.
- Parents are responsible for their children using any playground equipment.
- Group camping is available for 6 units or more. Names for each party must be given at time of reservation.
- If you require immediate assistance, please call security when the office is closed.

#### PAVILIONS

- All Pavilions are ADA accessible.
- Reservations are required and are non-refundable.
- Cleanup is the responsibility of the party renting the pavilion. Nails, tacks, or staples are prohibited from being used on the tables or pavilion posts.
- Driving up to the pavilion is permitted only to load and unload vehicle. Prolonged parking at the pavilions is strictly prohibited.
